The Federal Advisory Committee Act (FACA)

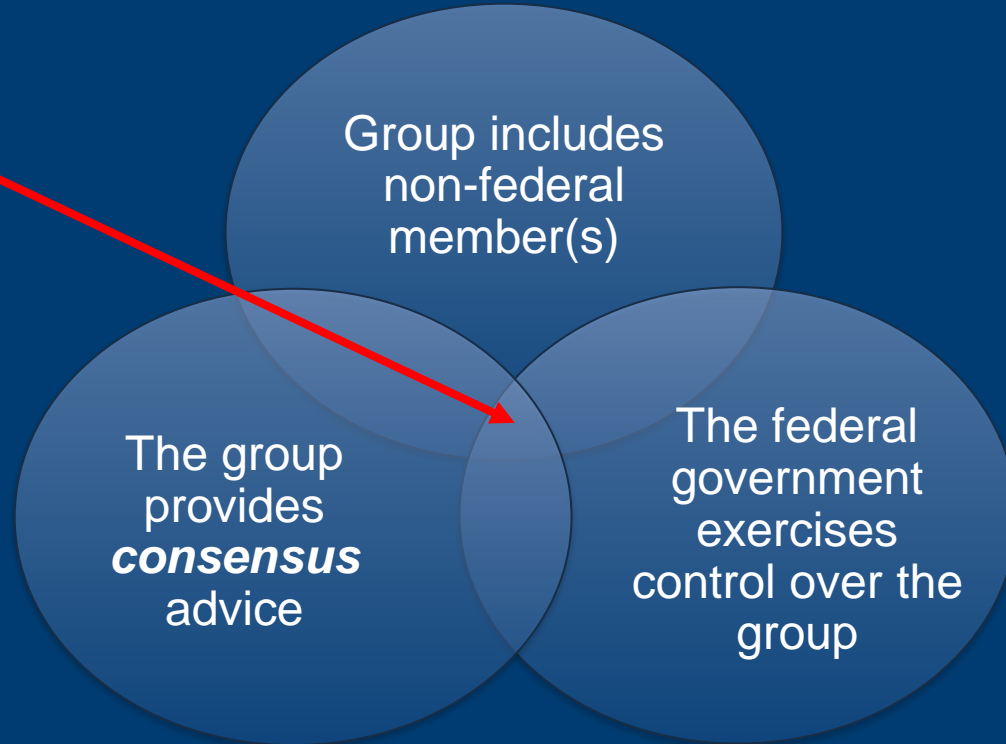
Sometimes the Federal Government can benefit from outside advice

FACA

The public has a right to know who is influencing Federal Government decision-making

When does the FACA apply?

FACA



Establishing Federal Advisory Committees

How

- Executive Order
- Statutory Mandate
- Discretionary Authority (including GSA Administrator)

Who

- Federal Employees, Special Government Employees (SGEs), & Representatives
- Committee Management Officer (CMO)
- Designated Federal Official (DFO)

What

- Must file a charter with committee details (e.g. costs, meeting frequency, termination date) before taking any action

FACA Meeting & Records Requirements



Generally, advisory committee meetings are noticed and open to the public



FACA Sec. 10(b): “[R]ecords, reports, transcripts, minutes, appendixes, working papers, drafts, studies, agenda, or other documents which were *made available to or prepared for or by each advisory committee* shall be available for public inspection and copying ... until the advisory committee ceases to exist”



Exceptions:

- Meetings involving classified info, personally identifiable info (PII), proprietary info, etc.

OG FAC Operations

Everyone Can Observe and Provide Input

The OG FAC will operate in accordance with all provisions of the Federal Advisory Committee Act (FACA) which requires:

1

All Meetings Be Open to the Public:

Information on how to attend will be available on the GSA Open Government Secretariat website, through social media, and posted at least 15 days before a scheduled meeting via a notice in the Federal Register.

2

Allows For Public Comment:

Written public comments will be accepted through the life of the Committee and oral public comments will be permitted when the agenda allows.

OG FAC - Term & Appointment

The Logistics of Serving



Members will serve for **one (1) to three (3) year terms**, and no member will serve for more than **six (6) consecutive years**.



The GSA Administrator will appoint all members, and the OG FAC is expected to be a continuing entity with **charter renewals every two years**.



Not more than 20 members total

- $\frac{2}{3}$ From public/civil society
- $\frac{1}{3}$ From the Federal, State, Local, and Tribal Government

OG FAC - Who Should Apply

Representation that Reflects American Society

- The OG FAC seeks diverse individuals from the American society to serve on the Committee.
- We value opportunities to increase diversity, equity, inclusion, and accessibility on our federal advisory committees and we encourage a cross-section of those directly affected, interested, and qualified to apply.



OG FAC - How Do I Apply?

Nominations Due May 28, 2024

Preparing your Nomination Package

Any interested person and/or organization may nominate qualified individuals for membership. Individuals are also encouraged to self-nominate. The following items must be submitted:

- (1) A **letter of nomination** stating the nominee's name and organizational affiliation(s), nominee's field of expertise, specific qualifications to serve on the Committee, and a brief statement of interest, including if the nominee is interested in serving as the Chair of the Committee;
- (2) A **professional resume or curriculum vitae (CV)**; and
- (3) A **short biography** (no more than two paragraphs) describing the nominee's professional and educational qualifications, including a list of relevant activities and any current or previous service on advisory committees.
